The NYC Triathlon was an especially heart-warming event given the tireless effort and dedication of Scott Redler. Scott not only finished the race in under 3 hours, be he did it on the bike Steven helped give him for his birthday. For the months leading up to the race, his life was devoted to raising awareness and money for The Leukemia & Lymphoma Society and The Steven M. Perez Foundation, successfully generating close to \$20,000 in donations. His hard work, for the Triathlon and for The Foundation, was featured in articles in three local newspapers. We are extremely proud of all that he has accomplished and genuinely appreciate his commitment to meeting his physical and financial goals.

The Foundation has great plans on the horizon and we all hope to continue to create positive momentum in helping those who are affected by leukemia and other related cancers. We have received formal approval as a 501(c)(3) status organization from the Internal Revenue Service. This entitles The Foundation to operate as a not-for-profit, and allows donors to deduct the value of their donation for tax purposes. We welcome your feedback and hope you enjoy reading about all of the wonderful activities we have been involved in over the past year.

The Steven M. Perez Scholarship Fund Scholarship Award Winners

The Foundation continues to seek out candidates who have been directly impacted by Leukemia or by the devastation of losing a family member to leukemia or other related cancers. In 2005, we awarded six college scholarships to graduating high school seniors. Each candidate was nominated by a high school counselor and several were referred to us through the Leukemia Unit at North Shore University Hospital.

Dean Bourazeris

On July 29, 2003, as Steven was a patient at North Shore Hospital, just down the hall, Dean's father succumbed to Acute Myelogenous Leukemia (AML). Our families passed in that hallway every day and shared a caring smile. Dean attended New Hyde Park High School and will be going on to college.

Maria Dente

Maria lost her young brother to a blood disease so rare that the only treatment available to him was the Leukemia Unit. With the support of her family and friends, Maria started a foundation linked to North Shore Hospital which provides nonmedical support for leukemia patients, including special food and equipment required for care but beyond the scope of normal medical insurance coverage. In the fall, Maria will attend Mount St. Mary College in Newburgh, NY. She is also a graduate of New Hyde Park High School.

Kellie Giangregorio

Kellie's mother received a bone marrow transplant in early 2004 to treat her leukemia. The family was hopeful for her recovery. However, she suffered a setback, and Kellie lost her mother in June 2004. Kellie attended East Islip High School and will use her scholarship for college expenses this fall.

Alexandra Berger

In a story similar to Kellie's, Alexandra's mother went through a grueling bone marrow transplant after being diagnosed with Chronic Myelogenous Leukemia (CML). Her weakened body rejected the transplant and Alex lost her mother in April 2005. She graduated from Syosset High School.

Kenny Zawistowski

Kenny also attended Syosset High School. He will go on to SUNY Geneseo in the fall to continue his education. His father died of leukemia when Kenny was in 6th grade.

Kristin Smith

Kristin was the only candidate to apply from the Half Hollow Hills School District, where Steven was once a student. She graduated from Half Hollow Hills High School West. She will attend Penn State in the fall. In the last year, her family suffered two severe blows - the death of her mother to cancer and the loss of the family's chief source of income. We feel certain that Kristin will put her scholarship funds to good use.

As we read the referrals from each high school counselor, there was a single unifying theme: each candidate had drawn strength from his/her loss and grown into a stronger, more caring adult. Most candidates have directed their energies to supporting their surviving family unit and serving to improve the lives of others in need. They found success in their studies and direction in life.

A total of \$8,250 was awarded in scholarships in 2005. Each of these stories highlights the difficulty of a life-threatening disease, and we are pleased that our scholarships can help provide these students with an opportunity to attend college. The Foundation continues to search for new ways for your generous donations to reach families in need of assistance.


tional bleacher chants. All the while, I don't think I saw Steven without a beer or some type of food in his hand the whole game and we're having a blast.

Supporting Children with Life Threatening Illnesses & their Families

Camp Sunshine is a unique setting supporting children with life-threatening diseases and their families. The camp has the distinction of being the only program in the nation to address the impact of a life-threatening illness on every member of the immediate family – the ill child, the parents and the siblings. Since its inception, it has provided a haven for nearly 16,000 families from diverse cultural backgrounds.

Families attend in groups according to the disease which affects their lives. A child with leukemia and his/her siblings and parents can get to know other families in similar situations. Camp Sunshine also offers programs for families dealing with other conditions, such as cancer, kidney disease, lupus, diabetes, and organ donor recipients, to name a few. In the summer of 2005, responding to the need of the community, Camp Sunshine designated one session to single parent families coping with lifethreatening illnesses. Each group attends a one-week session and many families return the following year to renew acquaintances and enjoy a respite from the reality and stress of everyday life.

The Steven M. Perez Foundation has received many letters of thanks from the children and their families who were sponsored in 2004 and 2005. They all express their tremendous gratitude to those who made it possible for them to enjoy the Camp Sunshine experience with their families. They describe the serenity of the environment, the competence of a caring staff, the medical support team and the fun of just enjoying normal life in a beautiful place. The parents are grateful to have discussion groups with other parents coping with similar problems, but most often, these letters stress the impact that a sick child has on the emotional stability of their siblings. At Camp Sunshine, the healthy siblings meet others in similar circumstances. For many, it is the first time they have a chance to express their feelings to someone in the same unique situation. Play dates, piano lessons and soccer practice often take a back seat to doctor's appointments, in-patient care and chemotherapy.

To sponsor each family, The Steven M. Perez Foundation donates \$1,500. In 2005, we were pleased to expand our donation to support ten families from the Long Island area. All the families chosen have a young child with leukemia.

In the coming months, Camp Sunshine will be upgrading its grounds to include a brick and stone walkway. Each brick and larger stone insert will be paid for with direct donations to the camp. The Steven M. Perez Foundation will have a stone with The Foundation's name and the message "Live Life to the Fullest". The \$1,500 donation will be added to their fund for capital improvements at their site in Maine.

Hurricane Relief

Hurricane Katrina has been one of the largest natural disasters our nation has experienced. Our hearts ache for our neighbors in Louisiana, Mississippi and Alabama whose homes, businesses and lives were destroyed by Katrina. We at The Foundation felt it appropriate to identify a way we could help.

We chose Texas Children's Cancer Center based in Houston, Texas. A division of Texas Children's Hospital, it is one of the world's premier research and health care education centers focusing on childhood cancer. It is the largest pediatric cancer and blood disease treatment center in the United States. Young patients suffering from every type of children's cancer and blood disorder come to Texas Children's Cancer Center from all over the world to receive the most advanced care. Texas Children's Hospital was caring for up to fifty-five children evacuated from New Orleans area hospitals by air ambulance or in private planes donated by friends of the hospital. About twenty of these children are critically ill. The Steven M. Perez Foundation has identified seven families devastated by Hurricane Katrina who, unfortunately, also have a child suffering from leukemia.

It is a tremendous honor to provide all the help that we can to these young victims and their families. We are proud to have been able to donate \$21,000 to Texas Children's Hospital. The Foundation has decided to allow the hospital's team of social workers the discretion to determine each family's needs on a case by case basis. It is our hope that the support provided by The Foundation will ease some burdens and help put these families back on track.



Spring Fling

On May 5th, twenty-five brave men and women took the stage at the Latin Quarter nightclub in New York City to be auctioned off for a date. Two of these women were Lauren Jarvis and Alana Yavers, friends of Dana.

The Leukemia & Lymphoma Society hosted The Spring Fling: Bachelor & Bachelorette Auction. The event includes an auction for dates with young singles in the New York area and with celebrities. Alana and Lauren were auctioned off as a double date, which was sponsored by The Steven M. Perez Foundation. The date included dinner at City Crab (compliments of Mitch Rosen) and drinks at Union Bar. One lucky guy won a date with the girls.

The event also included a silent auction and a raffle, as well as hors d'oeuvres and cocktails. About \$43,000 was raised by the Leukemia & Lymphoma Society and approximately 250 people attended. Gratitude for the generous contribution made by The Steven M. Perez Foundation was mentioned in the evening's program. All of the funds raised went to The Leukemia & Lymphoma Society.

Light the Night Walk

Last fall, Dana and her friends took part in the Light the Night Walk hosted nationwide by The Leukemia & Lymphoma Society. Light the Night Walk is a national fundraising campaign to commemorate and celebrate the lives of those touched by cancer. The mission of this evening Walk is to build awareness of blood cancers and to raise funds for those in need. This is a two-tothree mile non-competitive Walk; survivors carry white illuminated balloons while other participants carry red ones. The girls started at South Street Seaport and walked over the Brooklyn Bridge. During the event, participants are also invited to share in food, live entertainment and fun. The three 2004 Light the Night Walks in New York City were the most successful in the nation, raising nearly \$1.6 million. The event hosted over 7,000 walkers.

The Foundation sponsored a bowling lane and we enjoyed a great day of bowling and socializing with old friends and acquaintances. Jacob's Cure, a non-profit foundation, was established in September 2000 to save the life of Jacob, who is afflicted with Canavan disease, a devastating genetic brain disorder. Because Canavan is so rare, federal funding has been scarce towards therapeutic research in Canavan disease, so it is through the help of friends, family and a philanthropic community that Jacob and children like him may be cured. Canavan disease is a fatal genetic neurological disorder that deteriorates the white matter (myelin) in the brain. The white matter forms a protective coating around every nerve in the brain and spinal cord, to ensure that nerve impulses are properly transmitted from one part of the body to another.

It is the lack of white matter that leaves Canavan children incapable of performing the simplest functions. Even if they live to their full life expectancy - three to ten years - they become blind, paralyzed, prone to seizures, and increasingly lost to the world around them. Luckily, the Canavan gene has been identified, allowing at risk couples to carrier test for this deadly disease. Both parents must be carriers in order to have a child with Canavan (25% risk or 1 in 4). While prevalent in the Ashkenazi Jewish population, Canavan has recently been identified in people of other ethnic backgrounds as well. Jacob's Cure urges all expectant couples to seek genetic counseling.

Many of you may have seen NBC News a few weeks back feature Jacob and his interaction with his classmates in Purchase, NY. Jacob recently celebrated his 10th birthday and the news story highlighted his great attitude and his ability to socialize with his class-
